## Investment Objective & Philosophy

The Sub-Fund seeks to maximize current income and achieve above average total return over a full market cycle. It invests directly at least 80% of its net assets in fixed income. Securities and in derivative instruments that provide investment exposure to such securities. Fixed income securities include bonds, notes, and other fixed income instruments (including Rule 144A securities) issued by governmental or private-sector issuers. The Sub-Fund invests at least 50% of its net assets in mortgage-related securities, asset-backed securities, commercial-mortgage related securities guaranteed by, or secured by collateral that is guaranteed by, the United States Government, its agencies, instrumentalities or sponsored corporation; privately issued mortgage-related securities rated at time of investment AA- or higher by S&P or the equivalent as determined by at least one nationally recognized credit rating agency, or, if unrated, deemed to be of comparable quality by the Investment Manager; other obligations of the United States Government, its agencies, instrumentalities or sponsored corporations; and money market.

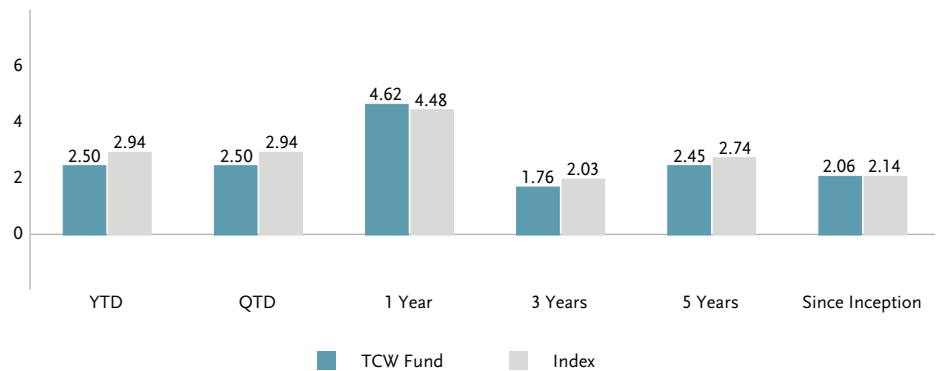

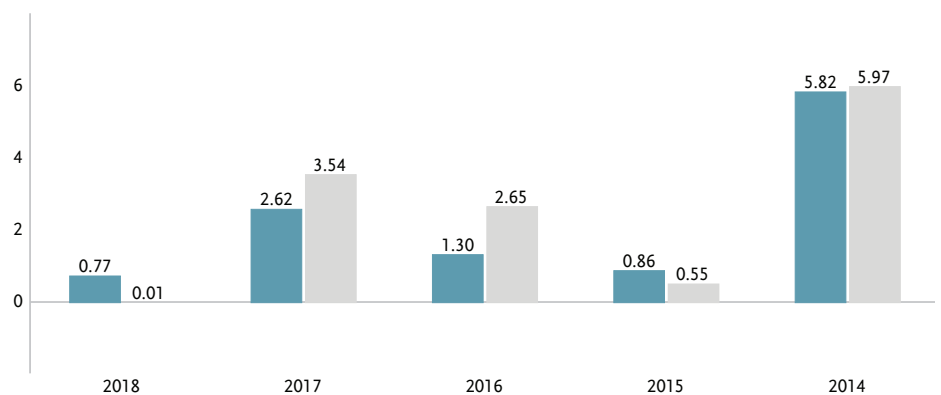

## Index

**Bloomberg Barclays U.S. Aggregate Bond** – A market capitalisation-weighted index of investment-grade, fixed-rate debt issues, including government, corporate, asset-backed and mortgage-backed securities, with maturities of at least one year. ## RISK

The Risk Level Indicator on the first page suggests the relationship between risk and potential returns when investing in the Sub-Fund. This Share Class has a ranking of 3, which indicates that there is typically a moderate risk for up and downturns in the net asset value. This ranking is typically used to indicate a level of risk that is greater than other Sub-Funds that invest in assets such as bonds issued by organizations with high credit quality domiciled in developed markets, but less than Sub-Funds that invest in assets such as equity. Historical data, such as is used in calculating the Risk Level Indicator, may not be a reliable indication of the future risk profile of the Sub-Fund.
