

# FISCH Convertible Global Defensive Fund

## EUR-Share classes | Hedged | 30 April 2020

### Strategy

The fund invests globally in convertible bonds of a high to very high credit quality. The maximum high yield allocation is 10%. The focus is on convertible bonds that exhibit high convexity, in order to exploit the full asymmetric return profile of the asset class. The objective is to outperform the Refinitiv Global Focus Investment Grade Convertible Bond Index through active management. Particular emphasis is placed upon downside protection in times of equity market weakness.

- Global convertible bond portfolio
- Defensive return from asymmetric yield through capital protection from convertible bonds
- Minimum 90% investment grade at all times
- Experienced team of 6 convertible bond portfolio managers and 21 analysts
- Foreign currency investments are hedged against the fluctuations of the fund's reference currency

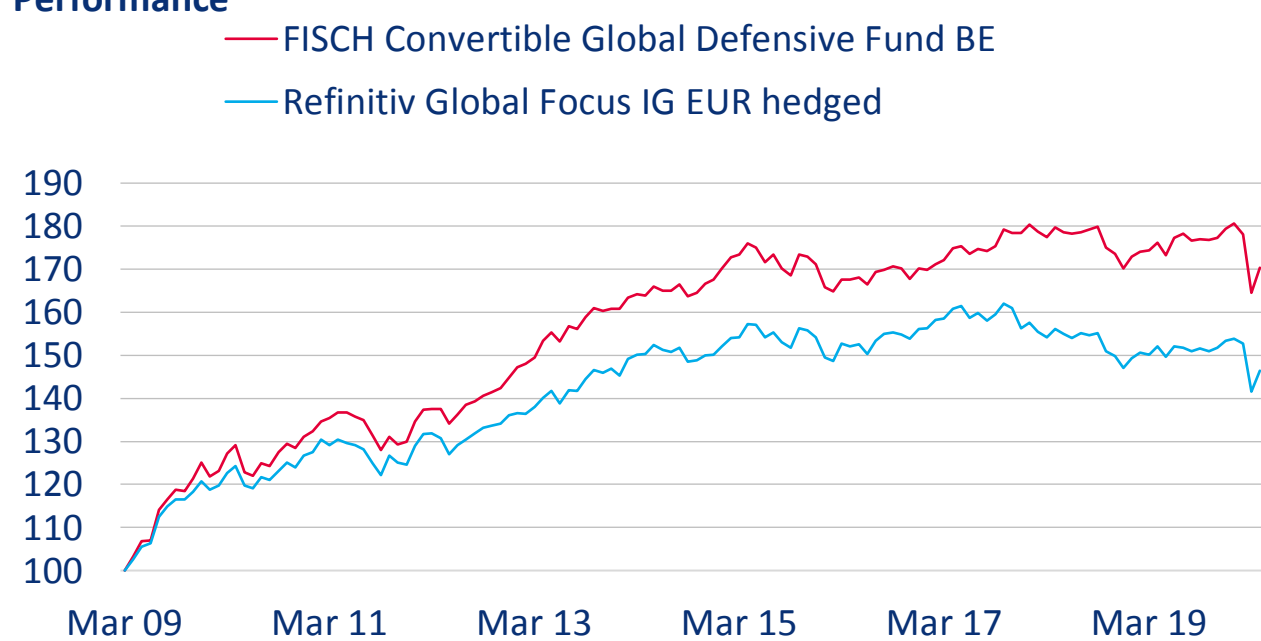

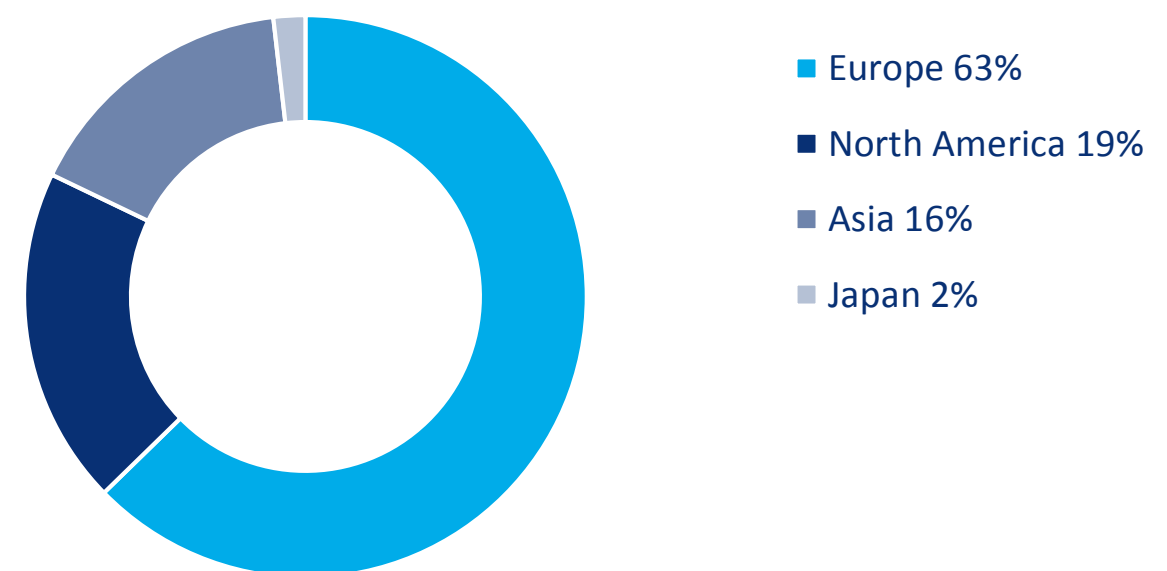
